

Competition Rules

Date: 12 November 2018

Who are we: The Fire & Feast Hamper Draw (referred to in these terms and conditions as the “competition”) is offered to you by Reed Exhibitions (Pty) Ltd (“Reed”) with company registration number 1997/020594/07 and telephone number 011 549 8300. Our principal place of business is 34 Culross Road, Bryanston, Johannesburg, South Africa. Reed Exhibitions (Pty) Ltd is the company that in these Rules is called “we” or “us”. We are the organizer of the Fire & Feast Meat Festival exhibition to be held 11-13 October 2018 at the Ticketpro Dome.

The law: This competition shall be conducted in accordance with the provisions of section 36 read with Regulation 11 of the Consumer Protection Act No. 68 of 2008.

Who can enter: Entrants must be over 18 years at the date of entry in order to participate in the competition. Entry into the competition is restricted to (manner of entry e.g. internet only or via post show survey link).

Exclusion: directors, members, partners, employees, agents of, or consultants to Reed Exhibitions (Pty) Ltd and/or its subsidiaries including their promotional partners and printers, their advertising and promotional agencies, suppliers of goods or services in connection with this competition or any other person who directly or indirectly controls or is controlled by Reed Exhibitions (Pty) Ltd or marketing service providers in respect of this competition, or any of the aforementioned persons' immediate family, including spouses, life partners, parents, children and siblings, business partners, or associates of a director, employee or agent of, a consultant to the Promoter are not eligible to participate or enter this competition. The competition is not open for entry by or on behalf of a legal entity.

There will be no cost to enter this competition. Unlimited entries per entrant will be accepted.

Competition Period: The competition runs from 20 November 2018 and will end on 27 November 2018.

The Winner: An entrant will be drawn at random from the comments made on the Fire & Feast Meat Festival Facebook post (referred to in these Terms and Conditions as the “winner”).

The Prize: The winner of the competition will be given a hamper and 2 entrance tickets to attend any one of the days of the Fire & Feast Meat Festival.

The winner may be asked to be present when the draw is taking place, participate in marketing activities as well as promotional elements that may be associated with the competition, including having his/her photograph taken, but he/she will be entitled to decline to do so.

The winner of the Fire & Feast Hamper Draw is not entitled to a cash alternative to the Prize and such Prize is non-refundable and non-transferable. We may at our discretion, change the dates of entry and/or the dates on which the competition is drawn.

Cash for Prizes? Prizes are not transferrable and cannot be exchanged for cash.

When will I know: The winner/s will be contacted via social media after the draw which will take place on 28 November 2018. Should the winner not be reached after three consecutive days attempts, a second draw will be held. The winner will be required to provide his/her certified proof of identification.

Unclear, illegible or incorrect information provided by the consumer will be declared as unacceptable and will result in the consumer's entry becoming invalid.

Should technical failures result in an invalid promotional entry Reed Exhibitions (Pty) Ltd or any of their affiliates or the participating partners will NOT be held liable.
